BRIEF HISTORY:

Under the administrative and operational control of the Mizoram Police Department, a Fire Brigade was set up on the 1.9.1972 in Aizawl. It was stationed within the vicinity of Aizawl Police Station. Later on more Fire Stations were established in other parts of the State. In Lunglei District, a Fire Station was established on 17.3.1975, Saiha District on 24.1.1991, Kolasib Sub-Division on 14.9.1992, Tlabung Sub-Division on 7.6.1995 and Serchhip Sub-Division on 17.4.1998. When new districts were created two more Fire Stations were set up in the districts of Champhai and Lawngtlai on 6.3.2008 and 25.9.1998 respectively without formal sanction of post. Staff were posted from the existing strength of other Fire Stations. On 17.8.1992 the Fire Brigade was re-organized and renamed it as the Mizoram Fire Service Organization under the Mizoram Police Department to form one full-fledged Police unit headed by Superintendent of Police. On 20.3.2008, a separate Directorate, independent of Police Department, under the direct control and supervision of Home Department was established. The Mizoram Fire Service Organization was thereafter renamed as the Fire and Emergency Services in the year 2004 to cater other emergency services in addition to providing services to the incident of fire.

ORGANISATION:

Under the direct administrative and operational control of the Director, the Directorate of Fire & Emergency Services is divided into Headquarters and Divisions. The Headquarters is in HuntharVeng Aizawl where the Director, Superintendent of Police, Addl. Superintendent of Police, Deputy Superintendent of Police, Chief Fire Officer, Deputy Chief Fire Officer and Assistant Chief Fire Officer (Divisional Fire Officer Post) are stationed.

For better administrative and operational convenient, the entire state is divided into two divisions viz., Northern Division and Southern Division. Northern Division includes Districts of Aizawl, Serchhip, Champhai, Kolasib and Mamit, the Headquarters of which is to be set up in Aizawl. The Southern Division is to have its Headquarters in Lunglei and it consists of the Districts of Lunglei, Lawngtlai and Siaha. Each Division is to be headed by Divisional Fire Officer under the close supervision of the Chief Fire Officer. The status and position of three newly created Districts of Khawzawl, Saitual and Hnahthial are yet to be considered and decided.

The Directorate or the office of the Director, Fire &Emergency Services or the Headquarters of Fire& Emergency Services is divided into Administrative Wing and Technical Wing. The Administrative Wing is manned by Ministerial Service of Police Department by nature of the post, being the duty post of Police Department. The posts of Gazetted Officers in the Administrative Wing of Directorate such as Director, Superintendent of Police, Addl. Superintendent of Police and Deputy Superintendent of Police are the duty post of Mizoram Police Service as per the Mizoram Police Service Rules.. Under the administrative, operational and disciplinary control of the Director, there is also a Technical Wing which is to consists of Gazetted Officers of Technical officers such as

Chief Fire Officer (CFO), Deputy Chief Fire Officer (Dy.CFO), Assistant Chief Fire Officer (ACFO), Divisional Fire Officer (DFO). These posts are to be either designated or recruited as per the Mizoram Home (Fire and Emergency Services) Department (Group B Post) Recruitment Rules 2017 as the case may be.

The subordinate officers or non-gazetted officers of the Department which constitute the technical and field staff consists of Station Officer (STO or Officer In Charge of Fire Station or Branch where he is posted), Sub-Officers (SO or Second In Command of the Station Officer or In Charge of a Fire Station or Branch where he is posted), Leading Fireman (LFM), Fireman (FM), Driver Operator (functional) Grade III, Driver Operator (Non-functional) Grade I, Driver Operator (Non-functional) Special Grade, Ministerial Staff posted from Police Department and IV Grades. The Leading Fireman and Fireman and Drivers are recruited and promoted as per the Mizoram Home (Fire & Emergency Services) Department (Group C) Recruitment Rules 2017. The Head Mechanic, Mechanic Grade I and Mechanic Grade II are recruited and promoted as per the Mizoram Home (Fire& Emergency Services) Department (Group B& C Post) Recruitment Rules 2014 and IV Grades are recruited as per the Mizoram Group D Post Recruitment Rules 2019.

There are also personnel attached to office of the Fire & Emergency Services from Police Department due to shortage of staff in the Organization.

ESTABLISHMENT:

Under the Home Department, Govt. of Mizoram, the Office functions under the administrative and operational control of the Director. He is assisted by the Superintendent of Police, Additional Superintendent of Police, Deputy Superintendent of Police, Chief Fire Officer, Deputy Chief Fire Officer, Assistant Fire Officer, Ministerial Staff, Drivers and IV Grade.

The office of the Headquarters is divided as under:

(A) Administrative Wing:

(i) <u>Confidential Branch:</u>

Deals with confidential matters, GO's transfer & posting, leave, awards and disciplinary proceedings of GO's etc,.

(ii) <u>Establishment Branch</u>:

Deals with all matters relating to non-gazetted officers and staff of ministerial staff on recruitment, promotion, transfer & posting, leave, disciplinary matters and pension cases, Purchase and issues of stationeries.

(iii) <u>Account Branch</u>:

Account Branch deals with all matters of pay and allowances, TA Bills, Contingency Bills, loans and advances, audit objections and all correspondences connected with financial transactions.

(B) Technical Wing:

(i) <u>Clothing & Equipment Branch</u>:

Deals with all matters of procurement of Clothing, uniforms and fire fighting equipments and their issues to different stations/staff.

(ii) <u>Construction Branch</u>:

Deals with all matters relating to construction of Fire Station, Quarters, building from planning, designing, execution; their maintenance and repairs and also with matters connected with Fire & Emergency lands.

(iii) <u>Reserve Branch</u>:

Deals with all matters relating to maintenance of service book, recruitment, promotion, transfer & posting, leave, disciplinary matters, training & refresher courses under State & National Institutions of the Executive Staff.

(iv) <u>Motor Vehicle Branch</u>:

Deals with all matters connected with purchase of vehicles/Fire tenders and their allotment, repair & maintenance, condemnation and their disposal after condemnation.
